What is Policy Dialogue? ການສົນທະນາດ້ານນະໂຍບາຍ ແລະມ່ນຫຍັງ?

- A policy dialogue is a reflective process that involves different people who discuss an issue in which they have a mutual – but not necessarily common . ການສົນທະນາດ້ານນະໂຍບາຍແລະມ່ນການທົບທວນຂະບວນການທີ່ມີການກ່ຽວຂ້ອງກັບບຸກຄົນທີ່ມີການສົນທະນາປະເດັນທີ່ຈຳເປັນ ແຕ່ບໍ່ຈຳເປັນຕ້ອງມີຫລາກຫລາຍທີ່ຄ້າຍຄືກັນ
- Policy dialogue can be conducted at any level of the food system where a problem is perceived and a decision, policy, plan or action needs to be made (adapted from WHO).
- There are thus different ways and means to implement policy dialogues and deliver messages to relevant stakeholders (directly and/or indirectly related to policy making processes), at different levels.

Why is Policy Dialogue needed?

- Policies could provide enabling or constraining environment for agricultural actors to be innovative and/or taking necessary transition towards sustainability.
- Without supporting policies, we can not expect for AE transition at medium and large-scale

How to organize Policy Dialogue?

- We are somehow in Step 3, but not limited, to restart from Step 1 as long as we identify and agree on policies / specific thematic topics and/or advocacy approach that should be targeted by ALiSEA
