Context of the experience


- The "Bamboo Provincial Strategy 2016-2020" for second phase has been approved by Provincial Governor.
- The Bamboo Project is facilitating the implementation this strategy
- The Bamboo Service Organization (not yet registered organization) as a local organization to ensure follow up of the program

1. SITUATION OF NOR HOK DRIED BAMBOO SHOOTS CROSS-BORDER VALUE CHAIN

High quality Hok dried bamboo shoots



Villagers harvest fresh shoots and sell to PU



Shoots are then boiled and then pressed in bag to remove water



When shoots are dried, they are packaged and sealed with label



PU member regularly check for dryness and quality while in oven



PU members cut, wash then slice in half shoots before boiling




Shoots are loaded into ovens



Dried bamboo shoots for domestic market and export to Vietnam

Mai Hok: Dendrocalamus hamiltonii



234 households in **8 villages** collecting 168 T equivalent fresh Creation of 10 000 working days of collection, (227 full time job during 2 month) Creation **of 4 village small entreprise** managed by 3 to 6 persons **0,9 M kip/ HH/ Year** Organic certificate

Bactom social entreprise purchasing high quality products from PGS

2. CHALLENGES FACED BY NOR HOK CROSS BORDER BAMBOO VALUE CHAINS

Challenges affecting value chain development: Nor Hok Dried Bamboo Shoots

On 5th December 2016, a post-season assessment of Pilot export case with Bac Tom in 2016 on Nor Hok High Quality Dried bamboo shoots stakeholders were conducted showed that the pilot case was time consuming and the governement recommended that Bac Tom go through 'normal' procedures.

However, three challenges were identified that block the value chain:

- 1. Delay for registration has been too short due to miss interpretation of Order 15 till Letter 073 clarification.
- 2. Even with time, there is confusion on registration process : Custom, Taxation, DOIC, seem not to have the same understanding of the rules.
- 3. There are difficulties on exportation : Cross-border procedures seem to be not enough coordinated between DAFO , PAFO and Cross border tax (phytosanitation requirement, export certificate)



Challenges and proposal Nor Hok Dried Bamboo Shoots VC development

Challenges	Proposal from Companies		
Delay for registration has been too short due to miss interpretation of PM Order 15 till MAF letter 073 clarification (Log and NTFP)	To do again a Pilot for the coming season (August 17)		
Even with time, there is confusion on registration process : Custom, Taxation, DOIC, seem not to have the same understanding of the rules.	Legal paper work clarified and made easy to certify compliance in Lao and in Vietnam, this will reduce time and costs for cross-border trading during the season Completion		
There are difficulties on exportation : Cross-border procedures seem to be not enough coordinated between DAFO , PAFO and Cross border tax (phytosanitation requirement, export certificate)	cross-border trading legal requirements should be done early so all legal papers should be completed before harvesting season		



Nor Hok Value Chain Perspective

- How to develop long term policy to facilitate this type of exports (Village Products, Processing in Villages, Certified) in order to increase commitments from traders?
- What are the other NTFP products facing similar constraints and how to solve it together?
- How to develop local market for this type of products?
